This table provides information on the 4<sup>th</sup> max. values for 2015 and 2016, the current 4<sup>th</sup> max. value for 2017, the current 3-year average, and the max. possible level for 2017 in order to remain in attainment of the ozone standard. Based on the current values, projected max. possible levels for 2018 are also included.
